Schedule Of Ownership

As part of the application process, an applicant must submit a schedule of ownership for all owners with 20%* or more ownership of the business.

For each owner, the following information must be provided:

1. Full Name;
2. Residential Address;
3. Social Security Numbers or Individual Taxpayer Identification Numbers;
4. Phone Number;
5. Email Address
6. Percentage Ownership; and
7. Government-Issued Photo ID

*ONLY Worker Co-op Applicants may apply as less than 20% owners. Documentation of authorization to apply on behalf of the Worker Co-op will be required.

Acceptable Forms of Government-Issued Photo ID

- NYS Learner Permit (must be current)
- NYS Driver Licenses (must be current)
- Non-Driver ID Card (must be current)
- United States Passport or Passport Card (must be current)
- Driver Licenses issued by another U.S. State, jurisdiction or possession, or Canadian Province or territory (these licenses must be current).
- NYC Identification Card (must be current)
